DeWine-Husted Priorities

- Gas Tax/Infrastructure Funding
 - 10.5 cents/gallon gas; 19 cents/gallon diesel July 1
 - o \$865 million annually
 - \$524 million for ODOT projects
 - \$381 million for local projects
- Children's Initiatives
 - \$550 million over two years for "wrap-around" services for at-risk students—after-school programs, mental and physical health services
 - Lead-paint removal
 - Increased home visits for pregnant women and young mothers
 - Crisis stabilization funds for families, children in need
- H2Ohio Fund \$900 million to clean Lake Erie and other waterways
- Managed Care Rebid/Reform; PBM Reform
- Opioids RecoveryOhio office

Ohio House of Representatives



- Rep. Larry Householder (R-Glenford) Ohio House Speaker
 - Householder won 26 of 60 GOP votes and 26 of 38 Dem votes
 - Speaker Householder becomes first in modern history to reclaim Speaker's gavel and first to win post with a minority of majority party
 - Democrats (labor unions) to have more influence
- Rep. Emilia Strong Sykes (D-Akron) Minority Leader

Legislative Priorities

Ohio House of Representatives

- Budget
- School Funding Reform
 - Reps. Bob Cupp (R-Lima) and John Patterson (D-Ashtabula): new school-funding formula based on 60% property tax and 40% income tax/wealth
 - More than \$1 Billion over two years
 - Likely Delayed
- HB 6 Clean Air Program
- Congressional Redistricting by June 14?

Ohio Senate

- Budget
- Regulatory Reform eliminate 2 rules for every 1 created
- SB 3 reform drug laws so low-level drug procession is a misdemeanor not felony; focus on treatment not incarceration
- Congressional Redistricting?

Governor DeWine's Budget

- \$69.55 Billion "all-funds" spending in FY20; \$71.28 Billion in FY21
 - Revenue Assumptions: \$48.4 billion in revenue over the next two years

FISCAL YEARS 2020 - 2021

- LCS Revenue Assumption: \$47.9 billion in revenue
 = \$500 million difference
- \$2.8 Billion in new spending from previous budget. Paid for by growing economy.
- Significant investment in children's services, education, family support
- Increase LGF from \$377.7 million in FY19 to \$412 million in FY20 and \$419 million in FY21
- H2Ohio fund "frontloaded" through appropriations, unspent funds in current FY
- No major tax cuts or changes



Budget Overview

Ohio House of Representatives – Sub HB 166

- Revenue Side
 - Split the difference on revenue estimates
 - New Tax Cuts
 - Eliminates personal income tax for those earning less than \$22,500 a year
 - Cut taxes by 4.7% for those earning between \$22,500 and \$88,800
 - Eliminate or Reduce Tax Breaks
 - Reduce from \$250k to \$100k exemption for "pass-through entities" (partnerships, LLCs, sole proprietorships, etc.)
 - small business owners will pay nearly \$200 million more per year
 - Eliminate tax credits for motion pictures, political contributions, corporate aircrafts
 - Requires ride-sharing companies to collect sales taxes
 - *Wayfair* standards—essentially requires on-line sellers and "marketplace facilitators" (i.e. Amazon, eBay, etc.) to collect sales tax
- Increase taxes on business by \$423 million; lowers taxes on individuals by \$500 million



Budget Overview

- Sub HB 166 Spending
 - \$69.71 Billion "all-funds" spending in FY20; \$71.66 Billion in FY21.
 - Increase of \$487.2 Million over Executive Proposal
 - \$125 million more for education "wrap-around" services
 - \$60 million more children's services
 - \$20 million for school buses
 - Increase from \$16 million to \$23 million funding for Ohio technical colleges
 - Increase primary higher education funding by \$22 million in FY20; \$20 million in FY21
 - Freeze tuition and general fees for incoming freshmen at four-year universities
 - Funds H2Ohio with \$85 million over two years. House looking at separate bonding entity to fully fund program
 - House paid for \$300 million in tax cuts and \$487 million in more spending by gutting H2Ohio fund
 - No changes to LGF
- Raise the age to buy cigarettes and other tobacco products from 18 to 21 years
- Require Medicaid to select one PBM
